Deriding the right to carry as "an article of faith" that "must be reined in". Hillary Clinton in 2014

"I really support everything President Obama said he would do through regulation on guns, but we're going to start the very first day and tackle the gun lobby." Hillary Clinton in a MSNBC town hall

*"This is about our community's safety and responsible gun ownership. This system will better enable our law enforcement agencies to ensure the security of all Hawai'i residents and visitors to our islands,"* Hawaii Gov. David Ige when signing SB 2954 (ACT 108) into law, which instructs law enforcement agencies to begin enrolling firearms applicants and gun owners registering their firearms into the FBI's "Rap Back" system, a criminal-record monitoring service.

## The Political Conventions and the Second Amendment

Both major political parties have now concluded their conventions. Let's look at the party platforms and how they address the Second Amendment.

<u>The Democratic Party platform</u> calls for stricter gun control through numerous avenues, listed below verbatim:

•We will expand and strengthen background checks and close dangerous loopholes in our current laws;

•Repeal the Protection of Lawful Commerce in Arms Act (PLCAA) to revoke the dangerous legal immunity protections gun makers and sellers now enjoy;

•Keep weapons of war—such as assault weapons and large capacity ammunition magazines (LCAM's)—off our streets;

•We will fight back against attempts to make it harder for the Bureau of Alcohol, Tobacco, Firearms, and Explosives to revoke federal licenses from law breaking gun dealers,

•Ensure guns do not fall into the hands of terrorists, intimate partner abusers, other violent criminals, and those with severe mental health issues;

•There is insufficient research on effective gun prevention policies, which is why the U.S. Centers for Disease Control and Prevention must have the resources it needs to study gun violence as a public health issue.

<u>The Republican Party platform</u> in support of Americans' Second Amendment rights is much longer, and goes into much greater detail:

•We uphold the right of individuals to keep and bear arms, a right which antedated the Constitution and was solemnly confirmed by the Second Amendment.

•We acknowledge, support, and defend the law-abiding citizen's God-given right of self-defense.

•We call for the protection of such fundamental individual rights recognized in the Supreme Court's decisions in District of Columbia v. Heller and McDonald v. Chicago affirming that right, and we recognize the individual responsibility to safely use and store firearms. This also includes the right to obtain and store ammunition without registration.

•We support the fundamental right to self-defense wherever a law-abiding citizen has a legal right to be, and we support federal legislation that would expand the exercise of that right by allowing those with state-issued carry permits to carry firearms in any state that issues such permits to its own residents. Gun ownership is responsible citizenship, enabling Americans to defend their homes and communities.

•We condemn frivolous lawsuits against gun manufacturers and oppose federal licensing or registration of law-abiding gun owners.

•We oppose legislation that is intended to restrict our Second Amendment rights by limiting the capacity of clips or magazines or otherwise restoring the ill-considered Clinton gun ban. (Justin Stakes and Larry Kean, National Shooting Sports Federation, 1 Aug 2016

The gun control crowd will never relent. From the above quotes and the platform of the Democrat Party, the threats to the Second Amendment are real. In Nevada and Maine the gun banners are introducing legislation for universal background checks. The National Institute of Justice has stated that universal background checks are unenforceable with requiring complete gun registration. In California there is legislation that would require background checks for all ammunition purchases; require any seller of ammunition to have a state license; and ban possession of large capacity magazines.

If there is a terrorist act – the answer is gun control. If some incensed murderer kills a couple of people – the answer is gun control. If there is a mass shooting by someone who is clearly mentally ill – the answer is gun control. Why is it that when some bad guy kills, the knee jerk answer is to infringe or negate the rights of the millions of us who are law abiding?

## **NICS Denying Gun Rights**

In October 2015 the FBI announced that were no longer processing NICS denial appeals. According to USA Today there is a backlog of 7,100 appeals as of Jan 16.

H.R. 4980, the Firearms Due Process Protection Act would force government to process and make a determination within 60 days. Congressman Tom Emmer, R-MN, is the sponsor. *The Gun Owners* (GOA), June 1, 2016.
